

Procedure for obtaining NOC for Movie Shooting

Municipalities and Corporations are issuing NOC for taking movie shootings in the limit of ULBs. It is one of the services of the ULBs and a source of revenue generation as well. In order to facilitate public the entire process of obtaining NOC for movie shooting is made online without physical touch point. The following procedure is adopted for issue of NOC.

Application for issue of NOC shall be made to the Executive Authority of respective ULBs.

1. On receipt of application, Commissioner shall scrutiny with reference to the suitability of the place, possibility of any damages to the public property or any nuisance being created etc.
2. During scrutiny of application, if any clarification is needed then query will be sent to the applicant in order to reply for the queries.
3. The inspection shall be done based on the requested locations of shooting.
4. After inspection if the Commissioner is satisfied, the demand notice shall be sent to the applicant for payment of fees through online.
5. The applicant shall pay the fees through online portal
6. On receipt of payment NOC shall be issued to the applicant.
7. The applicant can be downloaded the NOC from the portal.
8. If the competent authority is not satisfied by the application submitted, the same shall be rejected with reasons and intimated to the applicant through online.

Documents to be enclosed along with application for grant of NOC for Movie Shooting:

1. NOC from Police department

The permission shall be made with the following conditions:

1. In order to take movie shooting within ULBs, necessary permission shall be obtained from the local police station.
2. The shooting should not be carried out against the Government or against the rules.
3. In case of any damage to the public property or Municipal property during the movie shooting, you are held responsible.
4. Shooting should be carried out without disturbance to the public.
5. The shooting should be done only in the permissible area & time.
6. If above conditions are not followed properly, the NOC shall be cancelled without prior intimation.
7. This NOC is not transferrable.
